

## Privacy Policy

This policy (together with our terms and conditions of use and any other documents referred to in it) sets out the basis on which any personal data Palatine Private Equity LLP collects from you, or that you provide to us, will be processed by us (“Privacy Policy”). Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. We take your privacy very seriously. We will only use the personal information which we collect about you if you have opted into this. We will ensure that all such information is processed fairly and lawfully, in accordance with the EU General Data Protection Regulation (GDPR) and current English legislation including but not limited to the Data Protection Act 1998 and the Privacy and Electronic Communication Regulations 2003 and we aim to meet current internet best practice. ### 1. Information we collect

- 1.1 We collect information about you when you register with and/or use the Website and/or contact us (whether by email, telephone, post or otherwise). ## 2. Information we use

- 2.1 We use the information collected to provide and personalise our services, both on-line and off-line. This may include dealing with your enquiries, conducting quality assurance and/or training our staff.

- 2.5 We also use the information in our strategic analysis and our assessment of market trends. In particular, we use our Persistent Cookies to help us compile anonymous, aggregated statistics that enable us to understand how users use the Website and to help us improve the structure of the Website. We cannot identify you personally this way.
- 2.6 If you sign up to our mailing list the data that we collect from you will be transferred to, and stored at, a destination outside the EEA. It will also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff may be engaged in, amongst other things, the provision of support services. We will take steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.
